- 1.1. Prof Gilligan welcomed everyone to the meeting of the JNCC Support Co Board of Directors.

4. JNCC Annual Report and Accounts for the year ended 31 March 2014 (BD14 P01)

- 4.1. Prof Gilligan welcomed Mr Burton, JNCC's Finance Manager, to the meeting.
- 4.2. Mr Burton introduced the paper which presented the JNCC Annual Report and Accounts for the year ending 31 March 2014.
- 4.3. Mr Burton advised that there had been a significant accounting issue with the pensions information for senior staff that was included in the remuneration report. The issue had been resolved prior to the meeting and the revised figures had been sent to the National Audit Office.
- 4.4. Prof Gilligan acknowledged the number of amber-rated priority performance measures, where targets had not been achieved or exceeded.
- 4.5. Prof Gilligan congratulated directors and staff for their achievements during the year, despite the challenging circumstances.
