QUARTER THREE PERFORMANCE REPORT FOR 2012/13

1. Introduction

- 1.1 This report provides information on JNCC's financial position and progress in achieving priority performance measures for the quarter ending 31 December 2012. The Executive Management Board (EMB) has examined the performance and financial reports, and its conclusions and decisions are detailed in this report.
- 1.2 The Board is invited to comment on the overall performance and financial position at the end of the third quarter.
- 2. Performance against priority performance measures (PPMs) (Annex 1)
 - 2.1 Milestones have been devised for each PPM to help manage delivery by identifying stages when key elements will be delivered. A summary of the milestones for quarters 1, 2 and 3 and progress against them is shown at Annex 1, alongside the RAG assessment for quarters 1, 2 and 3.
 - 2.3 At the end of quarter 3, of the 21 priority performance measures, eight are rated 'Green' and are fully on track and ten are rated 'Amber/Green' as they are broadly on track but have some aspects that require attention.
 - 2.4 Notable achievements during quarter 3 include:
 - i. participating in the UK delegation to the 11th Conference of the Parties to the Convention on Biological Diversity in India in October;
 - ii. providing final advice (jointly with Scottish Natural Heritage) to Marine Scotland on recommended marine protected areas in Scottish waters;
 - iii. undertaking technical development of the NBN Gateway, leading to the initial release of a revised Gateway.
 - 2.5 Three PPMs are rated 'Amber/Red' with some aspects needing urgent action. These are:
 - i. PPM 2.4 (evidence quality assurance and standards);
 - ii. PPM 4.2 (identification of marine SPAs); and
 - iii. PPM 5.1 (offshore industry advice).
 - 2.6 PPM 2.4 has been adversely affected by the continued absence of key staff. Little progress on internal evidence quality standards was made in quarter 3 but a new delivery plan has been agreed with the aim of achieving substantial progress by the end of April 2013 and full completion by the end of June 2013. Work on UK standards is strongly influenced by work on the Habitats Directive Implementation Review (see PPM 3.2), which will need substantial effort in quarter 4.

- 2.7 Advice on possible SPAs in inshore Scottish waters (PPM 4.2) has suffered delays because of prolonged staff vacancies. Discussions with Scottish Natural Heritage are in progress to agree a revised timetable for the work.
- 2.8 PPM 5.1 is still rated 'Amber/Red' as problems persist, especially in providing advice on renewables. The position is gradually improving as new staff gain experience. A new Programme Leader has been appointed to direct this work area from April onwards.
- 2.9 PPM 1.3 (marine biodiversity monitoring) was rated 'Amber/Red' at quarter 2 but good progress has been made in bringing the work back on track. It is now rated 'Amber/Green'.
- 2.10 Throughout quarter 3 JNCC staff have continued to provide scientific advice in support of the response to ash dieback disease. This work has diverted staff resource from some PPMs (e.g. PPM 2.3, UK Biodiversity Framework) but effects on delivery have been relatively small.

3. Financial position (Annex 2)

- 3.1 A table showing spend to date and forecast against budget is given at Annex 2a, with forecast analysed by funding stream at Annex 2b. These tables show an estimated forecast underspend for the year as a whole of £63k. The forecast for the year indicates a £102k overspend on UK co-ordination grant in aid (GIA), a £74k underspend on reserved GIA and a £91k underspend on Defra marine GIA. Annex 2c gives a breakdown of forecast against budget by funding stream and by programme, highlighting where variances arise.
- 3.2 There has been a decrease in the projected underspend since the quarter 2 report. Resources have been redirected to alternative projects supporting the priority performance measures, and funds have been allocated to support new work on ash dieback.
- 3.3 The underspend will be reduced further as additional funds will be redirected to Cefas for evidence gathering work carried out during the final quarter of the year.
